3	Nature of duties	:	Data Analysis, interpretation, report preparation
4	Age Limit	:	Not exceeding 50 years as on the date of advertisement
5	Qualification / Essential	:	Essential Qualification: First class Master's Degree from a recognized University in Biochemistry/Microbiology/Biotechnology/Nutrition and Ph.D in related fields or 5 years R&D/Teaching/Working experience in Govt./Public Sector/Private Institutes as evidenced by published papers.
6	Desirable Criteria	:	Experience in meta-analysis, implementation research, operational research and clinical trials and data analysis/data interpretation.
