- 3) Since, the posts are temporary; the incumbents selected will have no claim for regular appointment at ICMR-NIN or continuation of his/ her services in any other project.
- 4) Presently serving or previously served ICMR-Project employees who have completed three years of project service are not eligible to appear for walk-in-interview. The maximum term of any Project Position in any or multiple projects, with breaks or without breaks shall be three years only.
