The offer/quotation received thereafter will not be considered. NIN, Hyderabad is not responsible for any postal delays. The sealed tenders will be opened on **23.11.2020 at 2.00 PM** in the office of Civil Engineer, ICMR-NIN, Hyderabad.
5. It is the responsibility of the contractor to visit the site before submitting their offer/quotation, for which the bidder may contact I/c Maintenance at 040-27197226/312 on all working days i.e. Monday to Friday except public holidays from 09.00 AM to 05.30 PM.
6. Director, ICMR-NIN, Hyderabad has the right to accept or reject any quotation(s) without assigning any reasons.
7. The work shall be completed within 30 days from the date of award of the work.
8. The labour engaged and working equipment brought by the contractor for the work shall be recorded in the ICMR-NIN Security Gate before entering into the premises and obtain necessary gate pass.
9. Payment will be made against the bill along with a statement of measurement taken in the presence of the contractor and the civil engineer of ICMR-NIN, Hyderabad.
10. The contractor/bidder should indicate their Registration Number, PAN, GST, Bank Account number for making payments to the contractor as well as statutory authorities.

11. Quotation by email or fax will not be accepted.
