

6. Director, ICMR-NIN, Hyderabad has the right to accept or reject any quotation(s) without assigning any reasons.
7. The work shall be completed within 30 days from the date of award of the work.
8. The labour engaged and working equipment brought by the contractor for the work shall be recorded in the ICMR-NIN Security Gate before entering into the premises and obtain necessary gate pass.

9. Payment will be made against the bill along with a statement of measurement taken in the presence of the contractor and the civil engineer of ICMR-NIN, Hyderabad.
10. The contractor/bidder should indicate their Registration Number, PAN, GST, Bank Account number for making payments to the contractor as well as statutory authorities.
11. Quotation by email or fax will not be accepted.
12. The ICMR-NIN, Hyderabad is not responsible for any damage caused to the labour/manpower engaged by the contractor for execution of the work.
